Coos County is now open to administer vaccines to anyone age 16 and over! Coos Health & Wellness is holding a special vaccination event for ages 16 and Over on May 8<sup>th</sup> with Pfizer vaccines. Please make an appointment through our new Community Event Scheduler link below.

Coos County vaccine administration is moving quickly due to the partnership of many area agencies. Bay Area Hospital, Bay Cities Ambulance, Bay Clinic, Coast Community Health, Coos Bay Fire Department, Coos Health & Wellness, Coquille Tribe, Coquille Valley Hospital, CTCLUSI, North Bend Medical Center, Nova Urgent Care, Southern Coos Hospital, and Waterfall Health Clinic. Many pharmacies also support vaccine distribution in

Coos County including Bi-Mart, Broadway Pharmacy, Fred Meyer, Rite Aid, Safeway, Walmart, and Walgreens. Please see sign-up information for events and clinics below.

In Coos County, approximately 71% of adults over 65 have received at least 1 dose of vaccine. Approximately 48% of the adult population in Coos County have received at least one dose of vaccine.

Oregon Health Authority lifted the pause on Johnson & Johnson after the FDA to begin administering the vaccine again with appropriate warnings about the rare side effects. You can read more details about this here: <https://sharedsystems.dhsoha.state.or.us/DHSForms/Served/1e3685.pdf>
