“COVID-19 vaccines are a critical tool in overcoming this pandemic. Findings from the extended timeframe of this study add to accumulating evidence that mRNA COVID-19 vaccines are effective and should prevent most infections — but that fully vaccinated people who still get COVID-19 are likely to have milder, shorter illness and appear to be less likely to spread the virus to others. These benefits are another important reason to get vaccinated.” Says CDC Director Rochelle P. Walensky, MD, MPH
